Please note the following:-

#### 1. Nominations for Management Committee (close 5pm Tuesday 8th March 2022)

- At the Annual General Meeting, all the members of the committee shall retire from office but shall be eligible upon nomination for re-election.
- Any two members of the association shall be at liberty to nominate any other member to serve on the management committee.
- Nominations for the committee positions are to be received by the secretary in writing at least 14 days prior to the Annual General Meeting (by 5pm on 8<sup>th</sup> March 2022). A valid nomination must be signed by the member, the member's nominator and seconder.
- To be eligible to vote members must be financial by CoB Tuesday 22<sup>nd</sup> March 2022.
- If a written nomination is <u>not</u> received for any position, then nominations will be taken from the floor for that position.

#### 2. To be eligible to serve on the Committee you must:

- Be over 18 years of age and be a financial member of the Association.
- Agree to abide by all the policies of the Association.
- Agree to make the club a priority by attending meetings and responding to other committee members.

#### 3. Voting:

- Voting may take place at the Annual General Meeting.
- For Committee positions, where more than one nomination is received, voting will be by secret hallot
- You must be a financial member of the Association to vote or to nominate any office holder.
- If voting is required more details on how to vote through Teams will be made available to members unable to attend the AGM.

#### 4. Further Details:

- Your commitment as a Committee member will include attendance at monthly Management Committee meetings during the year.
- As a Director of the Association you will be subject to the Australian Corporations Law, the Incorporated Associations Act of Queensland, the ARMA Committee Code of Conduct and Governance Charter.
